

**PRIVACY POLICY OF**  
**M3N, Inc.**

We are committed to safeguarding the privacy of our website visitors. The website located at [www.investM3N.com](http://www.investM3N.com) (“Site” or “website”) are operated by M3N, Inc. (“M3N”). Except as set forth below, this Privacy Policy applies to all services and sub-sites available under the domain name [investM3N.com](http://investM3N.com). By using the Site and submitting information to us, you consent to such transfers and the use and processing of information by us as described in this Privacy Policy. This Privacy Policy, developed in accordance with the EU General Data Protection Regulation (GDPR), the U.K. Data Protection Act of 2018, and the California Consumer Privacy Act (CCPA), is incorporated into the Site’s Terms of Use by reference, as if set forth fully therein. Your access and use of the Site will be deemed to indicate your acceptance of both this Privacy Policy and all of such Terms of Use.

M3N respects your privacy. We strive to use information to provide the best possible service while respecting the confidentiality of information we are entrusted with. This Privacy Policy outlines the types of personal information we may receive or collect when you use our services, as well as some of the methods we use to safeguard your personal information.

**1. INFORMATION WE COLLECT:** In order to better provide you with our numerous services, we collect two types of information about our users: Personally Identifiable Information and Nonpersonally Identifiable Information. Our primary goal in collecting information from you is to provide you with a smooth, efficient, and customized experience while using our site.

**a. Personally Identifiable Information:** This refers to information that lets us know the specifics of who you are. When you engage in certain activities on this site, we may ask you to provide certain information about you or your business by filling out and submitting an online form. It is completely optional for you to engage in these activities. If you elect to engage in these activities, however, we may ask that you provide us personal information, such as your first and last name, mailing address (including postal code), email address, company name, telephone, and

other personal identifying information. Depending upon the activity, some of the information we ask you to provide is identified as mandatory and some as voluntary. If you do not provide the mandatory data with respect to a particular activity, you will not be able to engage in that activity.

**b. Nonpersonally Identifiable Information:** This refers to information that does not, by itself, identify a specific individual. We gather certain information about you based upon where you visit on our site in several ways. This information is compiled and analyzed on both a personal and an aggregated basis. This information may include the Web site's Uniform Resource Locator ("URL") that you just came from, which URL you next go to, what browser you are using, and your Internet Protocol ("IP") address. A URL is the global address of documents and other resources on the World Wide Web. An IP address is an identifier for a computer or device on a Transmission Control Protocol/Internet Protocol ("TCP/IP") network, such as the World Wide Web. Networks like the Web use the TCP/IP protocol to route information based on the IP address of the destination. In other words, an IP address is a number that is automatically assigned to your computer whenever you are surfing the web, allowing web servers to locate and identify your computer. Computers require IP addresses in order for users to communicate on the Internet.

**2. COLLECTION METHODS AND USE OF INFORMATION:** We do not collect any Personally Identifiable Information about you unless you voluntarily provide it to us. You provide certain Personally Identifiable Information to us when you: (a) register for our services and register your email address with us; or (b) send email messages, submit forms, or transmit other information by telephone or letter when filling out the form or logging in. We may also collect information from you at other points on our site that state that such information is being collected.

We will primarily use your Personally Identifiable Information to provide our services to you, as required by our agreements with you. We will also use Personally Identifiable Information to enhance the operation of our site, fill orders, improve our marketing and promotional efforts, statistically analyze site use, improve our product and service offerings, and customize our site's content, layout, and services. We may use Personally Identifiable Information to deliver information to you and to contact you regarding administrative notices. We may also use Personally Identifiable Information to resolve disputes, troubleshoot

problems and enforce our agreements with you, including our Site Terms of Use, and this Private Policy.

3. **HOW WE USE YOUR INFORMATION:** The information M3N collects is used to comprehensively understand your needs and interests, and permits M3N to deliver a more consistent and personalized experience. For example, M3N may use your information to: a) Provide service and support; b) Update you on new services and benefits; and c) Select content to be communicated to you. We don't share your personal information with third parties. Only aggregated, anonymized data is periodically transmitted to external services to help us improve the Content of our Website and service. We currently use Google Analytics (traffic analysis, SEO optimization). Google Analytics: anonymous (ad serving domains, browser type, demographics, language settings, page views, time/date), pseudonymous (IP address).

4. **POLICY ON SHARING YOUR INFORMATION:** M3N will not sell, rent or lease your personal information to others. M3N may share personal information with companies working on our behalf and M3N owned business entities for the purposes detailed above. In any such cases, however, we require that the companies or entities that receive the information adhere to **privacy** standards and **policies** at least as restrictive as those M3N has in place.

Circumstances may arise, whether for strategic or other business reasons, in which M3N decides to sell, buy, merge, or otherwise reorganize businesses in various countries. Such a transaction may involve the disclosure of personal information to prospective or actual purchasers, or, conversely, the receipt of such personal information from sellers. It is M3N's established practice to seek appropriate protection for all personal information in advance of any such transaction.

We may have a good faith belief that access, use, preservation, or disclosure of such information is reasonably necessary to: (a) satisfy any applicable law, regulation, legal process, or legitimate governmental request, (b) detect, prevent, or otherwise address suspected fraud, security, or technical issues, (c) enforce any applicable Terms of Service, including investigation of potential violations thereof, or (d) protect against imminent harm to the rights, property or safety of M3N, its users or the general public as required or permitted by law.

Occasionally we may be required by law enforcement or judicial authorities to provide Personally Identifiable Information to the appropriate governmental

authorities. We will disclose Personally Identifiable Information upon receipt of a court order, subpoena, or to cooperate with a law enforcement investigation. We fully cooperate with law enforcement agencies in identifying those who use our services for illegal activities. We reserve the right to report to law enforcement agencies any activities that we in good faith believe to be unlawful.

**5. SITE COVERED BY THIS PRIVACY POLICY:** The M3N website ([www.investM3N.com](http://www.investM3N.com)) may from time-to-time link to third-party websites for your convenience and to provide easy access to additional useful information. Should you select such a link you will leave the M3N website. M3N does not control those sites nor their privacy practices, which may differ from M3N's practices and policies. Any personal data you choose to provide to, or that is collected by, such third parties is not in any way covered by the M3N Privacy Policy. We recommend that you read over such website's privacy policy before providing any personal information. A link to another website from M3N does not constitute an endorsement or representation about the value, quality, or usefulness of anything found on that third-party website.

We also use social buttons provided by services like WhatsApp, LinkedIn, and Facebook. Your use of these third-party services is entirely optional. We are not responsible for the privacy policies and/or practices of these third-party services, and you are responsible for reading and understanding those third party services' privacy policies.

**6. KEEPING YOUR INFORMATION SECURE:** M3N values your trust and takes it seriously. To prevent unauthorized access and disclosure, to maintain data accuracy, and to ensure the appropriate use of your information, M3N utilizes industry standard physical, technical, and administrative procedures to safeguard any personal information we collect.

**7. POLICY REGARDING CHILDREN:** The Network will never knowingly or intentionally collect any personal information about children under the age of thirteen (13). If the Network obtains actual knowledge that it has collected personal information about a child under the age of thirteen (13), that information will be immediately deleted from its database. Because it does not knowingly or intentionally collect such information, to the best of the Network's knowledge and belief, the Network has no such information to use or to disclose to a third

party. The Network has designed this **policy** in order to comply with the Children's Online **Privacy** Protection Act.

**8. COOKIES AND OTHER TECHNOLOGIES:** M3N may use cookies and other technologies to enhance your online experience and to learn about how you use our website and services. A “cookie” is a small file containing a string of characters that uniquely identifies your browser. While most browsers accept cookies by default, you can manually set your browser to refuse all cookies, accept cookies from specific websites, or highlight when a cookie is sent to your browser. M3N's servers may also automatically record information when you visit our website, including the URL that directed you to our website, your IP address, browser type and the date and time of your visit.

As is true of most web sites, we gather certain information automatically and store it in log files. This information includes Internet Protocol (IP) addresses, browser type, Internet Service Provider (ISP), referring/exit pages, operating system, date/time stamp, and clickstream data. We use this information, which does not identify individual users, to analyze trends, to administer the site, to track users' movements around the site and to gather demographic information about our user base as a whole. M3N will not use the information collected to market directly to that person.

**9. CONSENT WITHDRAWAL:** You have the right to withdraw your consent in relation to our processing of your personal information based on your consent. You can unsubscribe from our marketing e-mails at any time by emailing us back and type “unsubscribe.” You can withdraw your consent of receiving these emails at the moment of booking or at any time after that. Exercising your right to revoke consent, to opt-out, or to object against the use of your data for marketing purposes is free of charge.

**10. CHANGES TO THIS POLICY:** We reserve the right to change this Privacy Policy at any time. Such changes, modifications, additions, or deletions shall be effective immediately upon notice thereof, which may be given by means including, but not limited to, issuing an email to the email address listed by registered users and posting the revised Policy on this page. You acknowledge and agree that it is your responsibility to maintain a valid email address as a registered user, review this site and this Policy periodically and to be aware of any modifications. Your continued use of the site after such modifications will

constitute your: (a) acknowledgment of the modified Policy; and (b) agreement to abide and be bound by the modified Policy.

**11. MISCELLANEOUS PRIVACY ISSUES:** You must be at least 18 years old to have our permission to use this site. Our policy is that we do not knowingly collect, use or disclose Personally Identifiable Information about visitors that are under 18 years of age.

You should also be aware that when Personally Identifiable Information is voluntarily disclosed (i.e. your name, email address, etc.) in the discussion forums or other public areas on this site, that information, along with any information disclosed in your communication, can be collected and used by third parties and may result in unsolicited messages from third parties. Such activities are beyond our control and this Policy does not apply to such information.
